Two (2) \$1,000.00 Scholarships will be awarded for the 2016-2017 SY by the Paducah Teachers Federal Credit Union

### **Eligibility:**

To be eligible to apply for the Paducah Teachers Federal Credit Union Scholarship you must meet the following criteria:

1. You must be a Paducah Teachers Federal Credit Union member's child, grandchild, or the member must be your legal guardian.
2. You must be a graduating high school senior of an accredited high school. All scholarship recipients must attend college fulltime consisting of at least 12 hours per semester.
3. You must have a GPA of 2.5 or greater upon high school graduation.
4. Award recipients must be able to provide verification of acceptance/enrollment in college before the scholarship is awarded.
5. Credit Union associates and official family members as well as Supervisory Committee associates and family members and Scholarship Committee associates and family members are not eligible.

### **Additional Information Required:**

All application information must arrive at the Paducah Teachers Federal Credit Union no later than 3:00 CST, March 31, 2017.

Please check to ensure that you collected all necessary information and your application is complete.

1. Attach a copy of your official high school transcript provided by your high school guidance counselor.
2. **Attach only TWO letters of recommendation: ONE** from a high school teacher, counselor, coach or administrator and **ONE** from a non-family member for example community person, church member or an individual that knows about you and your future plans.
3. Complete Scholarship Applications (do not complete in pencil).

### **Mailing Instructions:**

All application information must arrive at the Paducah Teachers Federal Credit Union office no later than 3:00pm CST March 31, 2017. Applications that are incomplete, not in accordance with directions or not in the Paducah Teachers Federal Credit Union's possession by the above mentioned date will not be eligible.
